- (1) Please complete the **Pledge Form** to indicate the amount of your contribution and how you plan to give.
- (2) You can make one single payment to the St Joseph's Church Fundraising account. Payment can be by cheque or by direct transfer to the bank account. If you pay by direct bank transfer, you may use the form labelled **Payment Instruction to Bank**. Please return the completed form to St Joseph's and we can send them to your bank. If you send the form directly to your bank, please notify us so that we can track the payment. The bank account details are on the form.
- (3) You can, if you wish, pay monthly in instalments over a two year period. If you give in this way, please complete the form labelled **Monthly Standing Order Instruction**. As above, please return the completed form to St Joseph's and we can send them to your bank. If you send the form directly to your bank, please notify us so that we can track the payment. The bank account details are on the form.
- (4) Payment can also be made using the following **QR Code**.



- (5) If you pay tax in the UK and would like to Gift Aid your contribution, please complete the **Gift Aid Form**. If you Gift Aid your contribution, we are able to receive an extra 25% of your contribution from the government at no cost to yourself.

There are two locked wooden boxes where you can **deposit your completed forms**. One box is located in the porch, on the wall by the steps leading to the Choir loft. The other is located on the back wall, next to the area where the Crucifix is. Or, you can mail them to St Joseph's Church, Highgate Hill, London N19 5NE.
